- Complete the screens that follow to finish the registration process
- Once you've registered, you'll arrive at the dashboard
- Under **Wellness Screening**, select an option to schedule your screening

- Drink plenty of water
- Take all medications according to your regular schedule
- <Remember to fast - no food or drinks except water 9-12 hours prior to your appointment, unless otherwise advised by your physician (If you are unable to fast, please advise a Quest Diagnostics staff member)>

You will receive an email when your results are available online. Please note that results are best viewed on a desktop or laptop computer. Your results from previous years will also be available for viewing online.
