## SUMMARY ANNUAL REPORT FOR WILKS BROTHERS, LLC 401(K) PLAN

This is a summary of the annual report for the Wilks Brothers, LLC 401(k) Plan, EIN 45-2388948, Plan No. 001, for the period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Basic Financial Statement**

Benefits under the plan are provided through trust. Plan Expenses were \$10,018,285. These expenses included \$9,903,597 in benefits paid to participants and beneficiaries, \$7,814 in corrective distributions and \$15,964 in certain deemed distributions of participant loans and \$90,910 in other expenses. A total of 1818 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$59,436,163 as of December 31, 2022, compared to \$88,089,319 as of January 1, 2022. During the plan year the plan experienced a decrease in its assets of (\$15,195,629). This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$5,177,344) including employee contributions of \$4,714,506, employer contributions of \$2,066,898, rollover contributions of \$329,094 and earnings from investments of (\$12,287,812).
